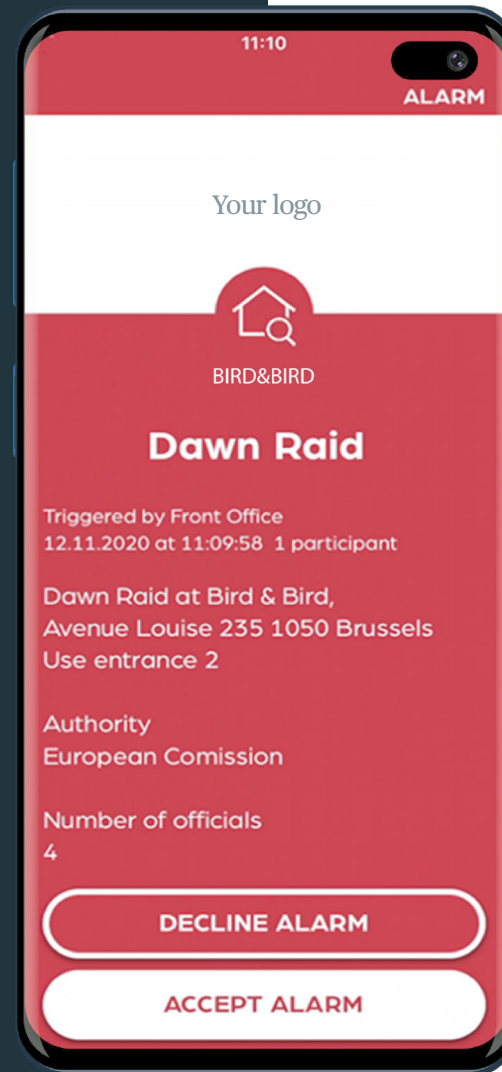

## The Challenge

A dawn raid takes place in the early morning.

Employees have been trained, but they're overwhelmed by the situation. Clear instructions for action are missing and predefined measures are not initiated.

In most companies, telephone lists are available. The reception staff go through these lists to inform key persons about the investigation.

However, these persons are often unreachable and the telephone numbers are not up to date.

This leads to serious delays and errors can be made.

## The Solution

As soon as the investigators arrive, the receptionist reports the dawn raid with one click, through a web-based interface available directly at their workstation.

The CEO, in-house counsel, compliance officer, external lawyer, and any other stakeholders preconfigured in the system are alerted in real time.

The search warrant is forwarded via an encrypted communication channel. The external lawyer is thus already informed about the current situation before he or she arrives. The app supports everyone involved with checklists and guidelines.

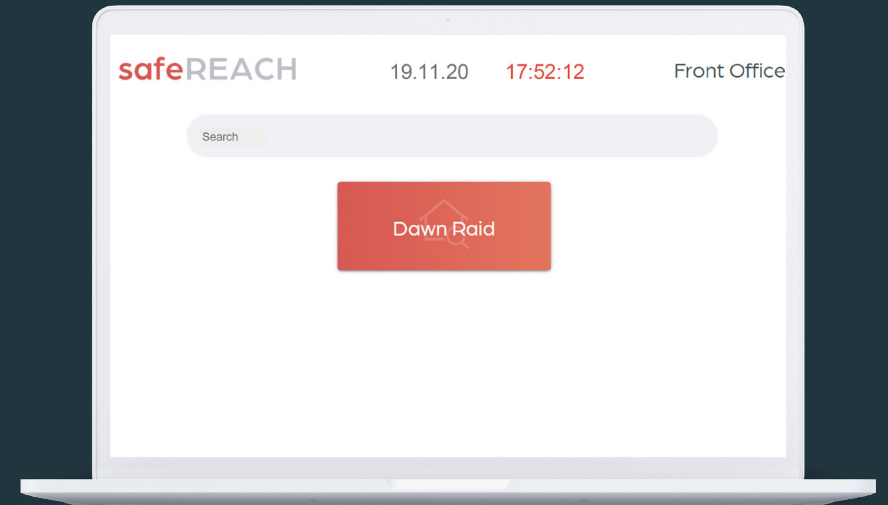
With this system you ensure a fast flow of information, receive clear guidelines and your company is optimally prepared for a dawn raid.

# Web-based Interface for the Reception

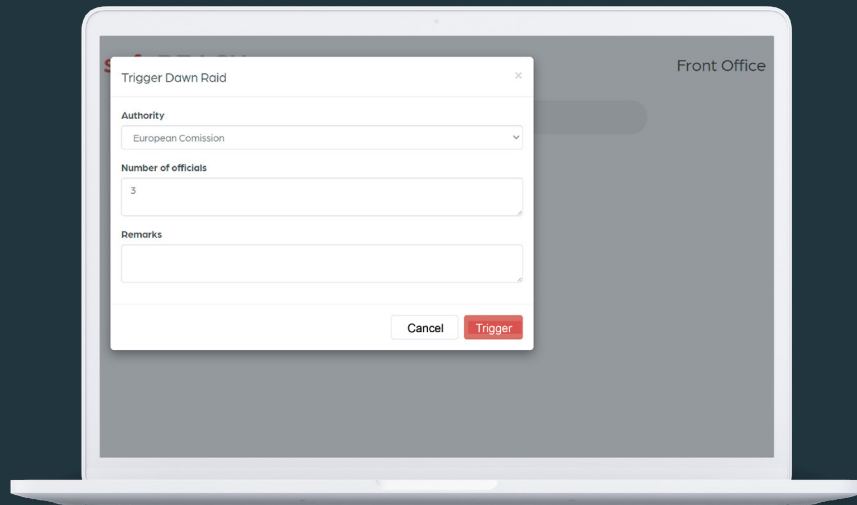
Reception staff trigger the alarm

# Features

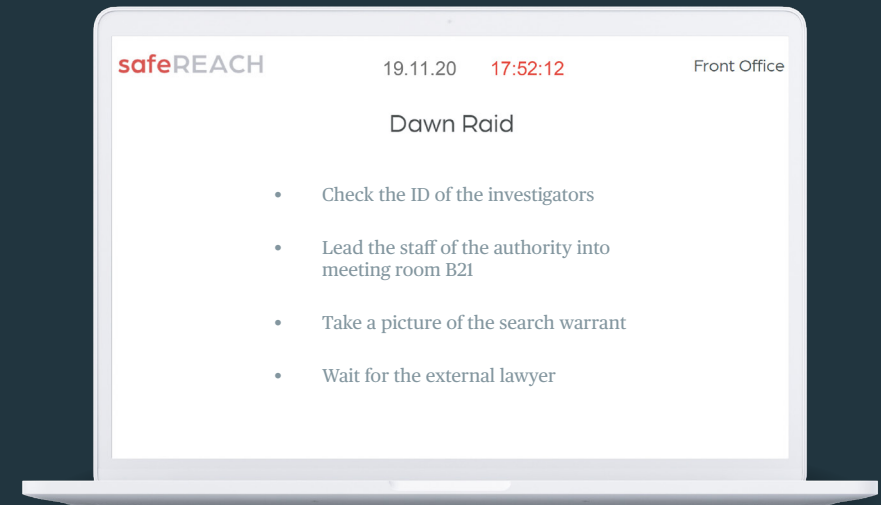
## Fast transfer of information

Immediately after triggering the alarm, reception staff receive clear instructions on what to do next.

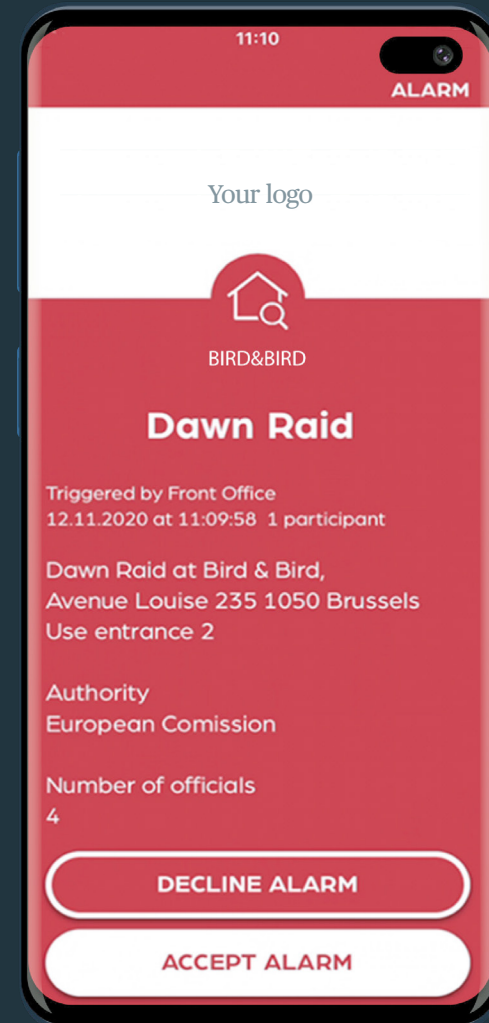

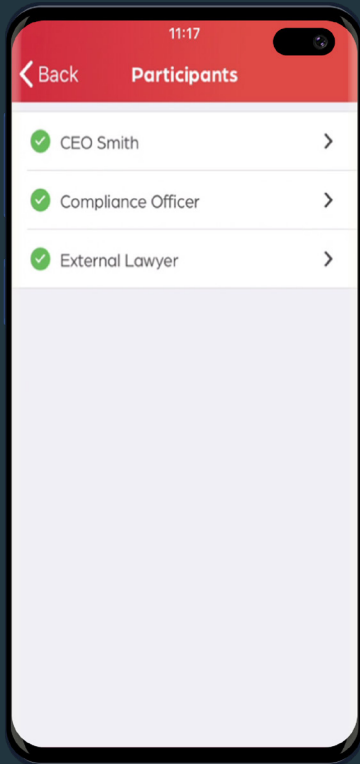
# The Dawn Raid App for CEOs, Compliance Officers and Lawyers

The content of the app can be customised to match the situation of your company.

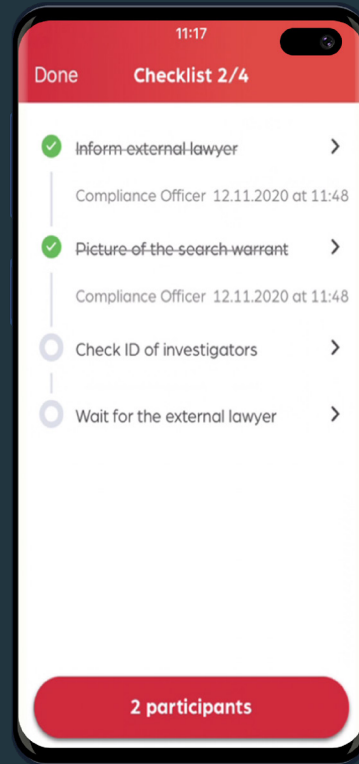

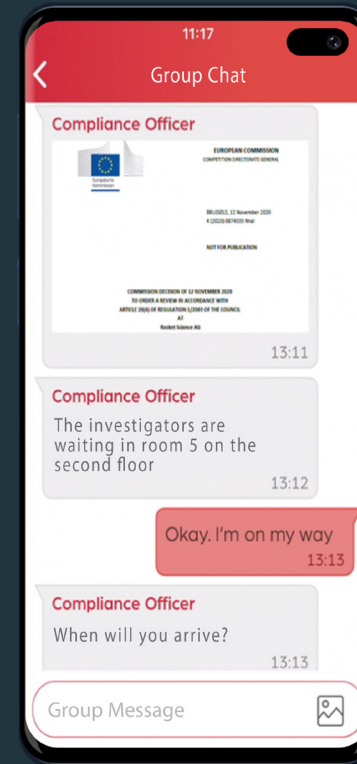

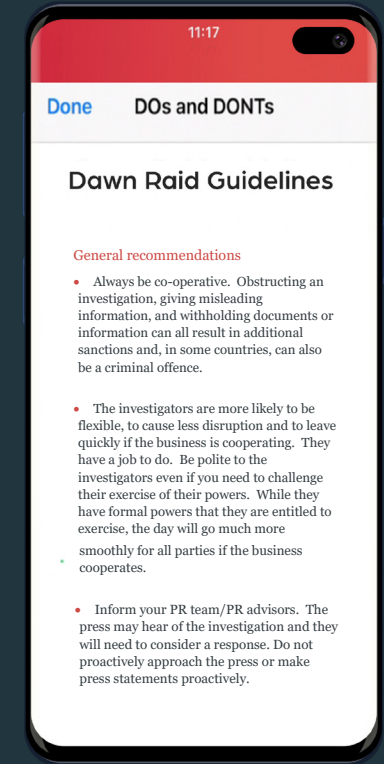
