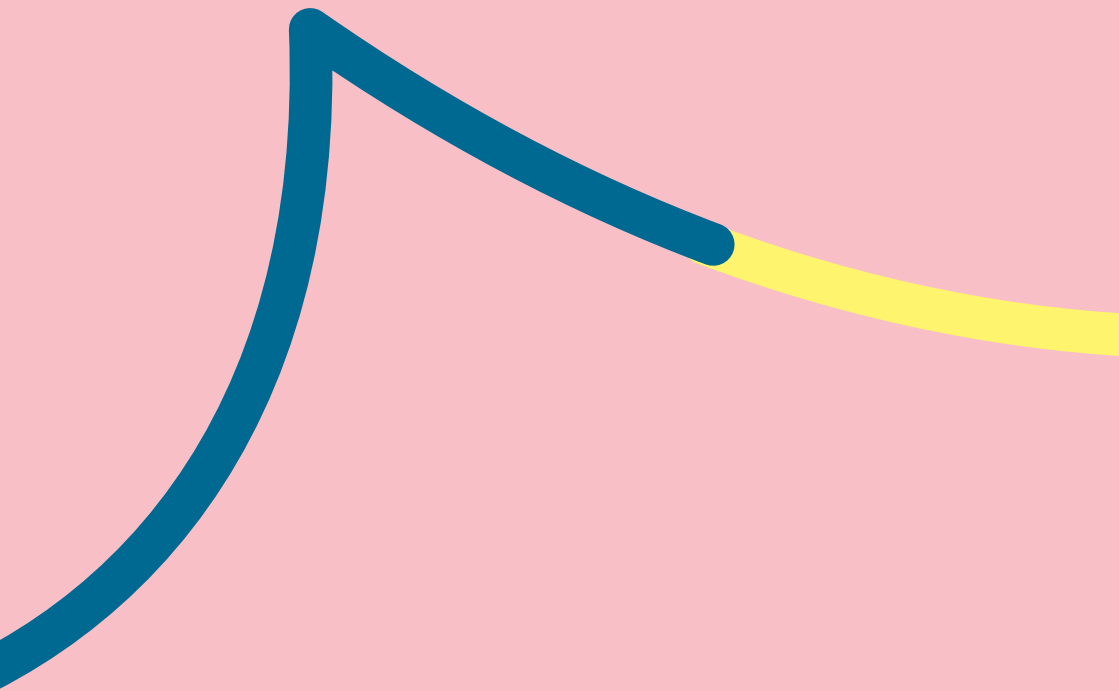


Cybersecurity

Pursuant to Article 32 of the GDPR, organisation must implement appropriate organisational and technical measures to keep the data safe. In addition, organisations must report data breaches to regulators within 72 hours if the breach results in a risk to the rights and freedoms of individuals. This formality may lead to the regulator assessing whether appropriate security measures have been adopted to prevent security incidents. We can support in auditing your information security framework, and recommend solutions to limit your cyber risk.
