# The start of your career:

## 1. Clerk

- When you apply for a summer clerkship here at Bird & Bird, you'll be in your penultimate or final year of law school.
- We love technology, but we also deeply value our shared humanity – so we don't screen out summer clerk applications with AI. Instead, your application is thoroughly and personally reviewed by our clerkship committee, which combines partners, HR and senior lawyers.
- If you're offered a summer clerkship, you'll have direct access to a junior lawyer buddy, a supervising partner and our office's managing partner. You'll also undergo rotations across a range of different legal teams.
- As a summer clerk, you're a vital part of our business and a valued member of our office. You'll be involved, not just on the legal side, supporting on a wide array of different Australian and international matters, but also with our warm and friendly culture, with social opportunities from summer clerk sports to special morning tea events.
- We're keen for you to really understand our business, so you'll also receive training on all our practice and sector groups, and our business services departments.
- Do you have a passion for doing good in business? If so, our committees covering pro bono, environment & sustainability, community impact & wellbeing and diversity & inclusion certainly welcome you and your commitment to making our business and our community better.

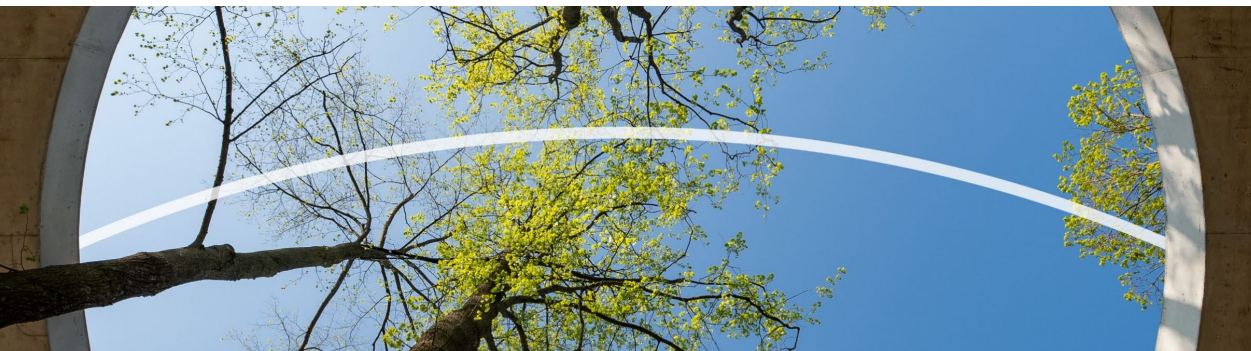
## 2. Paralegal / Graduate

- Once you've finished your law degree, and can work full time, you can join us as a Graduate, during either our February or July intakes and benefit from our graduate training programme run by the partners of the firm.
- You'll start your first 6-month rotation as a Graduate, with ongoing access to and support from buddies and partners.
- You'll now be able to dive more deeply into high-profile matters, working with colleagues in Sydney and from across our integrated international network.
- We know Practical Legal Training can be expensive. As a Graduate, you are eligible for financial support for PLT, as well as study leave, to help you to jump start your career.



### 3. Lawyer

- Once you're admitted, your title changes from Graduate to Lawyer. Celebrate your admission (and your new title) day with a paid day's leave from us!
- Your 6-month rotations continue from your role as a Graduate. We typically expect lawyers to have completed three separate rotations of 6 months, to support your professional development and nurture your technical proficiency. You receive the benefit of experiencing working across different areas of law and sectors, before you settle in a practice group.
- Your role in this stage of your career is to really learn to identify and analyse legal, factual, and commercial issues, always taking into account our client's needs.
- Once your rotations are complete and you've settled into a practice area, you're eligible for consideration for promotion to junior associate.



### 4. Junior to Mid Associate

- As an associate, you will support your team to find creative and innovative solutions for complex legal issues for our global clients.
- You will receive support from us to develop your professional profile and improve your marketing and networking skills.
- As your skills grow and you develop deeper legal knowledge, you may be considered for promotion to mid-level associate.
- As a mid-level associate, you will typically receive opportunities for client secondments, both physical and virtual. You may be invited to join one of many global programmes, such as the Career Transitioning programme for those that have transitioned from junior to mid-level associate or our Career Catalyst programme for high-achieving mid-level associates
- Recognising your increasing knowledge and professional growth, we reciprocate with increased benefits, which will likely also include opportunities to network with your global colleagues at overseas international practice group and sector group retreats.



## 5. Senior Associate

- Once you've been qualified for around 5+ years, you'll likely want to work with your supervising partner and HR on your application for senior associate.
- As a senior associate, you will manage matters and client relationships autonomously.
- At this stage, you'll be proactively promoting the firm's profile and your professional brand and building your own client connections and relationships.
- You'll also be very well integrated into your wider global sector and practice groups, working closely with colleagues from across our global network, and actively taking forward initiatives to support the global firm.
- As a senior associate, we're expecting you to be a role model and to mentor and develop your junior colleagues.
- As a senior associate or a special counsel, you may be invited to attend the Career Transitioning programme, Global Senior Associate programme, Future Leaders programme, or the Women's Development Programme either virtually or in-person.
- Senior associates can submit a business case to be considered for a promotion to a special counsel or partner.



## 6. Special Counsel to Partner

- By this stage, you're already making a name for yourself in the firm and in the legal profession. You can now apply to be recognised as Special Counsel, which is a global appointment.
- In some firms, this title is seen as an alternative to partnership, but that's not certainly how we see it. Many of our Special Counsel progress onwards to partnership.
- Ambitious candidates will be invited to attend our award-winning global development courses at our largest office in London.
- You will be demonstrating collective ownership for the delivery of high-quality client service in an efficient and effective way.
- As a senior member of the team, you will actively participate in industry, business and community events, developing your own client base, supporting our global partnership.
- Our UK-based partner HR team will support appropriate partner candidates as they continue their partnership journey.



# Summer clerkship application process



## First things first...

*Are you a law student in your penultimate or final year of legal studies?  
If yes, that's great! You are eligible to apply.*

Our summer clerkship process forms part of the Law Society of NSW summer clerkship programme – so we keep to the guidelines set by the Law Society.

## Who you are?

Every summer clerk, graduate, or lawyer we select has the potential to be both a leader of our global firm and a recognised leader in their chosen field of law.

If you have demonstrated academic excellence, combined with great “people skills”, enthusiasm, leadership and agility in problem solving, you will flourish with us.

Our lawyers have broad-ranging interests, from music to the martial arts. Most of our people have served in community roles, excelled in artistic endeavours, or pursued a sporting interest. Whatever your interest or passion may be, it demonstrates to us that you have the initiative to create for yourself a successful, exciting, and sustainable career in the law.







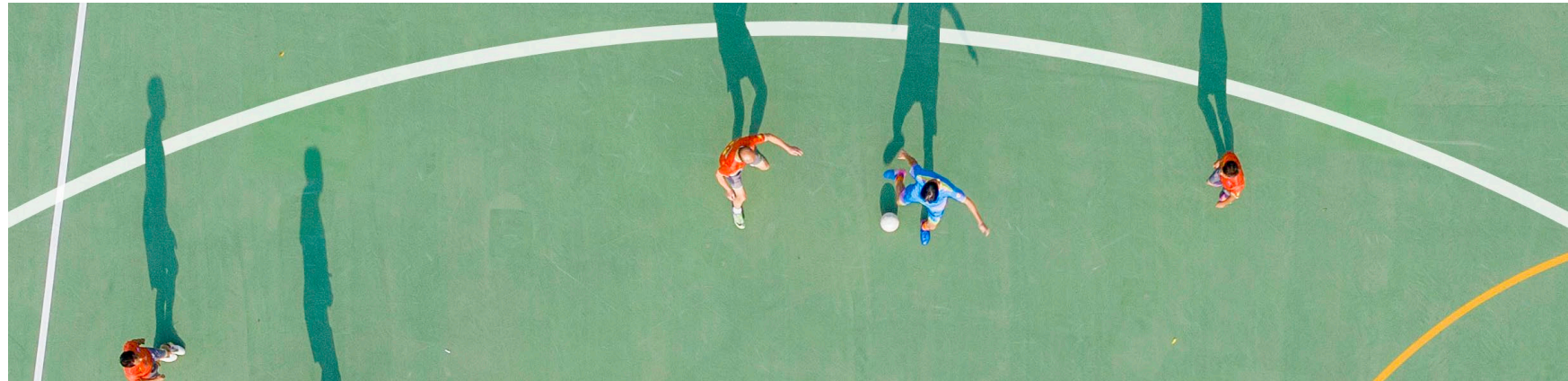
## Working with us

Although we are a tech-focused firm, we still prefer human interaction when it comes to selecting our people. We read every application that is sent to us, often several times over, just to ensure we are thoroughly assessing the potential of every applicant.

Summer clerks usually undertake rotations in two of our practice groups in the Sydney office, with each rotation lasting 4 weeks. You are likely to get exposure to most of our other practice groups by attending meetings and events during your time with us.

As a valued member of a specialist team, you will be involved in real legal work which adds value to our clients, and which will create an invaluable learning experience for you.

You will be supported by a buddy and friendly HR team throughout each of your rotations to ensure you get the most out of your time with us.

Once the formal process opens, you can apply by sending a **detailed cover letter, curriculum vitae, and academic transcript** to [sydsummerclerks@twobirds.com](mailto:sydsummerclerks@twobirds.com)

- If current semester transcripts have not been released by your university by the due date, please submit transcripts as soon as possible to the above email address.

Late November – Early February	Summer clerkship period



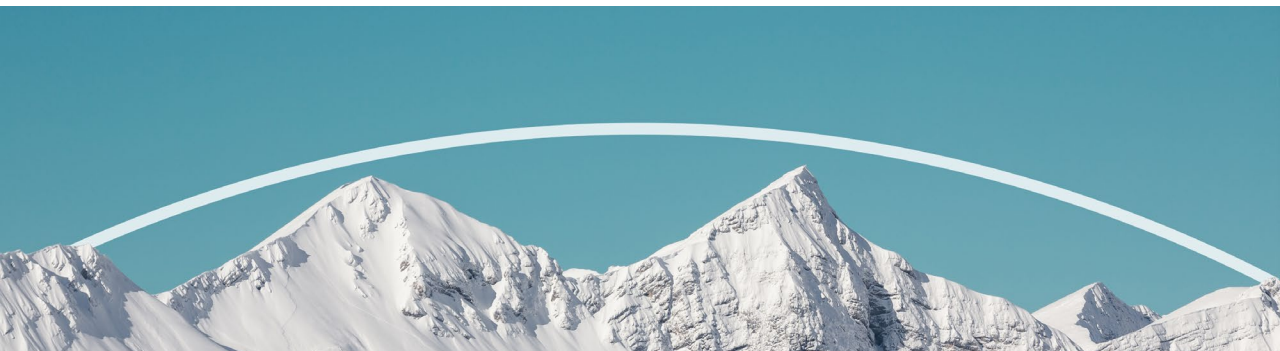


## *Need handy hints on making an excellent application to Bird & Bird?*

1. Start your application early! Save and re-read your answers before submitting. Try to avoid a last-minute email on the last day of applications to remove the stress of an unforeseen IT issue. Early applications show you are keen and organised.
2. Be clear and concise in your cover letter. Link your unique achievements and interests back to the firm information you have gleaned from our website, social media, or other interactions with us.
3. Do your research. If you genuinely want to work at Bird & Bird, this will shine through. Don't be caught out by generalising or, even worse, having the wrong firm's name in your application. Yes, it really happens.
4. Make sure you are aware of our firm's areas of expertise and what differentiates Bird & Bird from our competitors. We value our point of difference. Show us that you are familiar with our strengths and that you mirror our enthusiasm for technology and the digital world.
5. Don't be put off if you do not have legal experience. All experience is valuable, so focus on the skills you have learnt and how these apply to the role of a clerk or future lawyer.



6. Maximise the opportunity to demonstrate your legal knowledge and commercial awareness in your communications with us. We don't expect you to be legal experts, but the ability to call on your prior experience and apply that to a different situation is a skill that you will need to develop as a lawyer, so start early. Let your personality shine through (keeping it professional). Firms want to know what makes you tick, your likes and your passions, as well as learning about your skills.

8. Ask a family member or friend to proof-read your application before submitting it. Sometimes, a fresh set of eyes helps to spot any spelling or grammar mistakes. Always keep a copy of your application, so that you are able to refer to it prior to your interviews.

10. If you don't get through the process with the firm of your choice, don't be disheartened. Focus on looking for the next opportunity. They really do come up all the time!

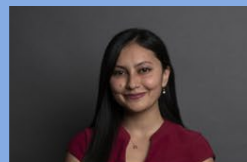

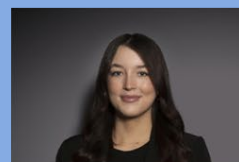
